2. This Consent Form will automatically lapse when the purpose for which your consent was obtained ceases to exist.
3. The images/information will be used for the stated purpose. The Council will not use the images or audio/visual recordings taken for any other purpose. The information will not be disclosed to any external organisations.
4. We will not include details or full names (which means first name **and** surname) of any person in an image on our website, or in printed publications, without specific permission. For example, we may include the full name of a competition prize winner if we have your prior consent. However, we will not include the full name of a model used in promotional literature without your specific consent.
5. We will not include personal email or postal addresses, or telephone or fax numbers on our website or in any printed publications. The processing of the images/information will comply strictly with the principles of the Data Protection Act 1998.
