
#### Head of Disabled Children's Service



We will keep all parents informed on what their child is working on so it can continue at home.

# **Transport**

As many of you who use St Quintin transport know, we struggle at times with the service we received from Westway. Over the last few months we have been looking at other providers with Raj who many of you know co-ordinates the school transport service, We are happy to say a new company has been appointed and hopefully will be able to support us afterschool and in the holidays.

Transport criteria still apply as before but we are hoping the new provider will provide us more suitable buses and drivers. Please let us know if you have any concerns over the transport from St Quintin.

The Keyworker service is now based at St Quintin. It supports families with children under 6 years. # **Children with Disabilities Team News**

There have been a few changes in the team since the last newsletter. Erika Endlein has left to become a manager of the Hammersmith and Fulham Children with Disabilities Team. Kate Young has taken over from Rita Perl as manager of the Occupational Therapy Service. Jade Noble has joined us as a Social Care Worker. Lauren Carre and Mary Kargbo have joined us as Social Workers.

Mostly the staff group has remained the same and I hope this continuity has helped you to get an efficient and responsive service from us.

Tracy Cooper is our Direct Payment support worker. She works closely with Paula Ellery to support parents using the service. The rules for Direct Payments can be a bit confusing so I sent out a "frequently asked questions" letter to parents about this in October.

The Children with Disabilities panel has looked at around 160 requests for individual packages of support in the past 12 months. In order to get such a high numbers of support packages agreed for the coming year, parents will not automatically be invited to attend the 2013/14 panels.

Your social worker, social care worker or keyworker will update last year's form with you and if there are no significant changes in your circumstances it is likely that your child's package for 2012/13 will be allowed to continue. You will be sent a copy of the panel form that has been agreed along with a letter setting out the procedure for resolving any disagreements. However if you do want to come to panel to discuss your child's package that's fine. Please ring me on **020 7598 4924** and I'll give you a date when this can happen.

#### **BFST News**


#### Staffing:

The BFST has had some staff changes over recent months – Carolina Sharman (Clinical Psychologist/Joint Team Manager) is currently on maternity leave with Jane Iles covering her clinical sessions. Kate Doherty (Clinical Psychologist) left on maternity leave in early January, with some cover for her leave being provided by Cat St Clair.

#### Managing demand for services:

The team continues to review the best way of meeting demand for their services with some cases being open to them for lengthy periods. With this in mind, a more regular review of goals will take place with families and other professionals working with the child in order to focus the BFST's input around key issues and to limit input or close cases where progress is not currently achievable. This will create capacity to respond to new referrals promptly as they are received. Collaborative approaches with their colleagues in education and social services continue to be explored in order to achieve the best outcomes for children they work with."

## **Tri Borough News**

There is a lot in the papers about the efficiencies The Royal Borough of Kensington and Chelsea Westminster City Council and Hammersmith and Fulham have achieved by amalgamating back office functions in a number of areas.

For services to disabled children we are particularly aware of the need to be organized in a way that is compatible with the Draft SEN Legislation which we anticipate will come into force sometime in late 2014. We are keeping a close eye on the Pathfinder Authorities who are piloting some of the ideas contained in the draft SEN legislation.

With these factors in mind we have begun to explore whether there is a case to create a tri borough Disabled Children's Service. So far this has just been pulling out facts and figures and making comparisons in terms of the types of service being provided, how many children get a service, what are their needs and how much is being spent.

We believe this information will then help us to identify where we can amalgamate back office functions, do things to a higher quality or more efficiently across all the boroughs by adopting best practice, and where we might be able to buy in services more effectively by offering some economies of scale. We also believe this could be an opportunity to further develop local services which could ultimately prevent children needing to use overnight or boarding school services in the future.

We hope to have done a lot of this homework by the end of March 2013 and will be coming to you with a range of ideas, some big, some small, some very much in draft, and some thought through in more detail, for discussion feedback and comment. We hope this will be a useful process for everyone concerned.
