Two Remarkable Houses in Kensington

One of the most extraordinary buildings of the nineteenth century, Leighton House is a jewel of the East in West London.

Leighton House, built from 1865, is the former home of Frederic, Lord Leighton, the great Victorian artist, and is a unique venue for the understanding and appreciation of Victorian art. Alongside paintings, drawings and sculptures by Lord Leighton, the Museum houses works by other artists of the period, including Burne-Jones, De Morgan and Watts.





From 1875, Linley Sambourne House, 18 Stafford Terrace, was the home of Punch cartoonist Edward Linley Sambourne, his wife Marion, their children and servants.

Originally decorated by the Sambournes in keeping with fashionable Aesthetic principles, the interiors evolved into wonderfully eclectic artistic statements. Remarkably well-preserved and complete with its original interior decoration and contents, it is a unique time capsule of late Victorian middle-class taste.
