## **9. MOTION FOR DEBATE**

Whilst noting that the Kensington and Chelsea Primary Care Trust are reducing their spending by £10 millions during 2006/07 as required by the Department of Health and the Strategic Health Authority as they work to eliminate their cumulative £26 million deficit, the Council is concerned that some of the savings in the PCT's Financial Recovery Plan will adversely affect important services provided through the PCT to Borough residents, including those provided in partnership with the Council.

The Council is, for example, concerned by the case put to close the Joan Bartlett Nursing Home, by the £200,000 budget cut to the Princess Louise Nursing Home, by the reductions in voluntary sector grants, HIV and drug and alcohol services funding, as well as cuts to

MIND-Many Hands Project, Age Concern home bathing service and the EPICS day centre.

The Council will continue to work closely with the Primary Care Trust and local partnership bodies to minimise the effects of health service reductions on our residents, and will urge that adequate consultation is carried out with service users and residents on the proposals in the PCT recovery plan.
