(Regulation (EC) No. 852/2004 on the Hygiene of Foodstuffs, Article 6(2))

This form should be completed by food business operators in respect of new food business establishments and submitted to the relevant competent authority 28 days before commencing food operations. On the basis of the activities carried out, certain food business establishments are required to be <u>approved</u> rather than <u>registered</u>. If you are unsure whether any aspect if your food operations would require your establishment to be approved, please contact the Royal Borough of Kensington and Chelsea for guidance.

### Notes

#### What is Registration?

Registration is a notification by the food business operator of "each establishment under its control that carries out any of the stages of production, processing and distribution of food"

Registration is required under Article 6(2) of Regulation (EC) 852/2004

The Royal Borough of Kensington and Chelsea will keep a database of this information, which is entered on a public register. This information may requested with due regard to Freedom of Information and Data Protection legislation.

#### Do I need to register?

All food business establishments (i.e. each separate unit of their food businesses) need to be registered except establishments which need to be <u>approved</u> under *Regulation (EC)* 853/2004, e.g. Food Manufacturers.

If in doubt, please contact the Royal Borough of Kensington and Chelsea for guidance.

#### How do I register?

Registration is free of charge. Once completed, this form needs to be returned to the following address:

#### When to register

Food business operators should register their food business establishments with the Royal Borough of Kensington and Chelsea at least 28 days before food operations commence.

## If the activities of your food business change

After this form has been submitted, food business operators must notify <u>any</u> changes to the activities stated above to the Royal Borough of Kensington and Chelsea and should do so within 28 days of the change(s) happening.

#### Some definitions

**"Food business"** means any undertaking, whether for profit or not and whether public or private, carrying out any of the activities related to any stage of production, processing and distribution of food;

Please note that Food businesses can include restaurants, cafés, bars, home caterers, market stalls, schools, nurseries, chemists, etc. This list is <u>not</u> exhaustive.

"Food" includes drinks, snacks, confectionery, baby milk, chocolate bars, wrapped and sealed food, etc. This list is <u>not</u> exhaustive.

**"Food business operator"** means the natural or legal persons responsible for ensuring that the requirements of food law are met within the food business under their control;

"Establishment" means any unit of a food business;
