INSTRUMENT OF GOVERNMENT

CHRIST CHURCH AND HOLY TRINITY CHURCH OF ENGLAND PRIMARY SCHOOLS FEDERATION

- 1. The name of the federation is Christ Church and Holy Trinity Church of England Primary Schools Federation.
- 2. The names of the schools in the federation are:
 - i) Christ Church CofE Primary School, Chelsea
 - ii) Holy Trinity CofE Primary School, Sloane Square
- 3. Both schools are voluntary aided schools.
- 4. The name of the governing body is: The governing body of Christ Church and Holy Trinity Church of England Primary Schools Federation.
- 5. The governing body shall consist of:
 - a. Two parent governors
 - b. One LA governor
 - c. One Staff governor
 - d. One Headteacher
 - e. Three Co-opted governors
 - f. Ten Foundation governors (to outnumber the total of other categories by two)
- 6. Total number of governors: Eighteen.
- 7. The term of office of all governors, *other than ex-officio,* is four years.
- 8. Foundation Governors shall be appointed as follows:
 - a. One appointed by the London Diocesan Board for Schools;
 - b. Three appointed by the Parochial Church Council of St Luke and Christ Church Chelsea
 - c. Three appointed by the Parochial Church Council of Holy Trinity, Sloane Square
 - d. One appointed by the Deanery of Chelsea
- 9. a. The holder of the following offices shall be a foundation governor ex-officio:
 - i) Incumbent of St Luke & Christ Church Chelsea
 - ii) Incumbent of Holy Trinity, Sloane Square

- b. The Archdeacon of Middlesex shall be entitled to appoint a foundation governor, to act in the place of the ex-officio governor, whose governorship derives from the office named in 9a (i) above, in the event that that ex-officio governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21 (1) of the Regulations.
- c. The Archdeacon of Middlesex shall be entitled to appoint a foundation governor, to act in the place of the ex-officio governor, whose governorship derives from the office named in 9a (ii) above, in the event that that ex-officio governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21 (1) of the Regulations.
- 10. a. The Archdeacon of Middlesex shall be entitled to request the governing body to remove the ex-officio foundation governor referred to in 9a (i) above and to appoint any substitute governor.
 - b. The Archdeacon of Middlesex shall be entitled to request the governing body to remove the ex-officio foundation governor referred to in 9a (ii) above and to appoint any substitute governor.
- A Trust exists in relation to Christ Church CE Primary School Chelsea.
 Two Trusts exist in relation to Holy Trinity CE Primary School Sloane Square.
- 12. The ethos of both schools is

Recognising their historic foundation, the schools will preserve and develop their religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The schools aim to serve their community by providing an education of the highest quality within the context of Christian beliefs and practice. They encourage an understanding of the meaning and significance of faith, and promote Christian values through the experience they offer to all pupils.

- 13. This instrument of government comes into effect on 1 September 2019.
- 14. This instrument was made by order of The Royal Borough of Kensington and Chelsea Local Authority on 19 July 2019.
- 15. A copy of the instrument must be supplied to every member of the governing Body (and Executive head teacher if not a governor), any trustees and to the London Diocesan Board for Schools.
