

## Kensington and Chelsea Council Filming and Photography Fees 2024-2025

### Notice of No Objection (NONO)

If your cast and crew is larger than five persons and/or using equipment that is not handheld, a **notice of no objection** is required for filming/photography in the Royal Borough of Kensington and Chelsea. You are required to have a copy of the NONO on site during your filming.

The following are the fees charged to obtain a NONO by crew size:

Small (cast and crew up to 5)	£94
Medium (cast and crew 6 to 15)	£218
Large (cast and crew 16 to 50)	£287
Extra Large (cast and crew 51 plus)	£424

### Administration Fees

Kensington and Chelsea's Film Service charges the following per hour fee by crew size for processing your application:

Small (cast and crew up to 5)	£200
Medium (cast and crew 6 to 15)	£200
Large (cast and crew 16 to 50)	£250
Extra Large (cast and crew 51 plus)	£374
Cancellation Fee	Price dependent on notice given

### Location Fees (Parks and Squares)

Kensington and Chelsea's Film Service charges the following per hour fee by crew size for filming in its public parks and squares:

Small (cast and crew up to 5)	£218 first hour £560 to £875 half day £940 to £2,500 full day
Medium (cast and crew 6 to 15)	£625 to £1,125 half day £1,250 to £3,125 full day
Large (cast and crew 16 to 50)	£1,250 to £4,375 half day £3,125 to £8,750 full day
Extra Large (cast and crew 51 plus)	£2,500 to £10,000 half day £4,375 - £14,975 full day

### Special Location Fee

In recognition of the complexity of arranging filming on Portobello Road and Albert Bridge, the Council will apply an additional fee, the price on application.

## Council Property Location Fees

All set as price on application.

## Concessions

The following qualify for a 50% discount on fees with a minimum fee of £37.50 charged and all other fees price on application on a case by case basis.

- Stills photography where not more than 2 people involved
- Student
- Registered charity
- Voluntary organisation
- Educational film (not for cinema or TV distribution).

## Parking Fees

Kensington and Chelsea's Film Service can suspend parking bays for technical vehicles. Requested suspensions must be submitted with a completed suspension form along with an annotated map showing which bays are to be suspended.

All residential bay suspensions must be replaced with an alternative Pay-By-Phone so that residents are not impacted.

The lead time on a Parking Suspension is ten-days, however suspensions can be put through in five days for a late application fee of £357, in addition to the pay per day costs.

## Highways Fees

The following are specific fees the Kensington and Chelsea Film Services charges for activity on the highway:

- A Temporary Highway Consent (THC) Licence is required to place any structure on the highway, for example a dolly and track or lighting.

- A Mobile Lifting Operations Licence is required for mechanical lifting equipment on the highway, such as forklift trucks, cranes. Parking suspensions are also required within the works area, or to control traffic flow.
- A Temporary Traffic Order is required to close roads or impose a prohibited turn or access/exit of a road. All parking withing a road closure requires suspending. There is an 8 week lead in time required for a road closure.
