If an annual licence is surrendered for cancellation, a pro-rata refund will be made of the fee paid for each complete month, which remains unexpired, subject to the Council's costs being covered. (The date of surrender will be deemed to be the date the licence is received by the Council).

** If the premises are currently licensed for ear piercing or manicure ancillary to the main business and an application is made to vary the licence to include other treatments, the difference between the Annual Special Treatment Licence fee and the reduced fee for the ancillary treatment would be payable. If the variation is to add more than one additional treatment room, then a further fee of £94 is payable for each additional treatment room

Extensions beyond 11.00pm

An additional charge is payable in respect of applications which include an extension of hours beyond 11.00pm on the basis of 1% of the scale fee for every half hour (or part thereof) the licence extends beyond 11.00pm on any individual night of the week. E.g. a premises with a capacity of 100 persons that remains open on Friday and Saturday until 2.00am would be charged an additional fee of **£11.40 X 12 = £136.80**

- . Withdrawn or unsuccessful applications will be charged for the amount of officer time spent in dealing with that application. **If the Council's costs in dealing with the application are higher than the fee paid, no refund will be made.**
- . If the Council's calculations indicate that the fee initially charged is an over-assessment an appropriate refund will be made. If the Council's calculations indicate an under-assessment the licence will not be granted until the full fee is paid.
- . If because of alterations, etc., the maximum number of persons permitted at the premises is varied, no adjustment of the current licence fee will be made.
- . No refund will be made on the grounds that the number of persons attending these entertainments has been substantially and consistently less than the maximum permitted number.
