Ref: 27 Pembridge Square, Notting Hill, London.

We are reviewing outstanding items to complete the works at 27 Pembridge Square; in particular, the conditions specified for planning and listed building consent.

The boundary wall copings, piers and pier caps have now been completed to the required details as discussed.

Regarding security upgrading of the rear basement door; whilst we do not believe that the existing rear basement door is original to the building, we are happy to keep the aesthetic appearance unchanged by replacing like for like. A reinforced replacement would be visually identical in detail, with security glass, and steel reinforcement completely hidden within the timber body of the door. Only a burglar attempting to break through the door would be able to tell the difference.

It was suggested that the existing door be re-sited if possible, or otherwise stored on site. There is no suitable location to re-use an exterior door inside the premises, and we therefore propose that the door be stored carefully in the garage. We trust this is acceptable.

Details of the railings and finials to the front basement light-well, by B Levy and Co, are as previously approved. As these railings fall outside our client's demise, formal instruction needs to be made by Marsh and Parsons, who act for the freeholder. They are currently engaged in cleaning and refurbishment of the external façade, which requires full-height scaffolding. It is therefore proposed that installation of the railings follow after these works have been completed, so as to avoid any damage.
