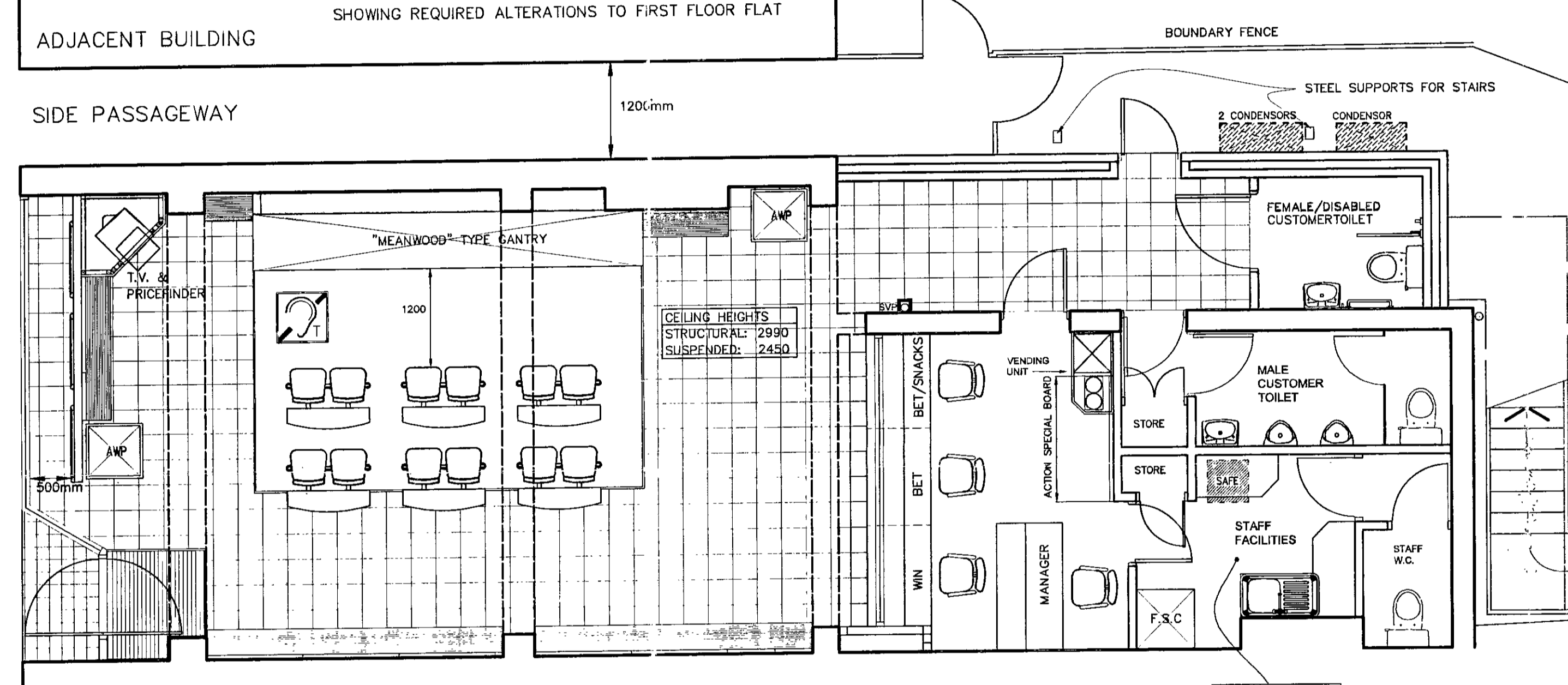


PROPOSED FIRST FLOOR PLAN
SHOWING REQUIRED ALTERATIONS TO FIRST FLOOR FLAT



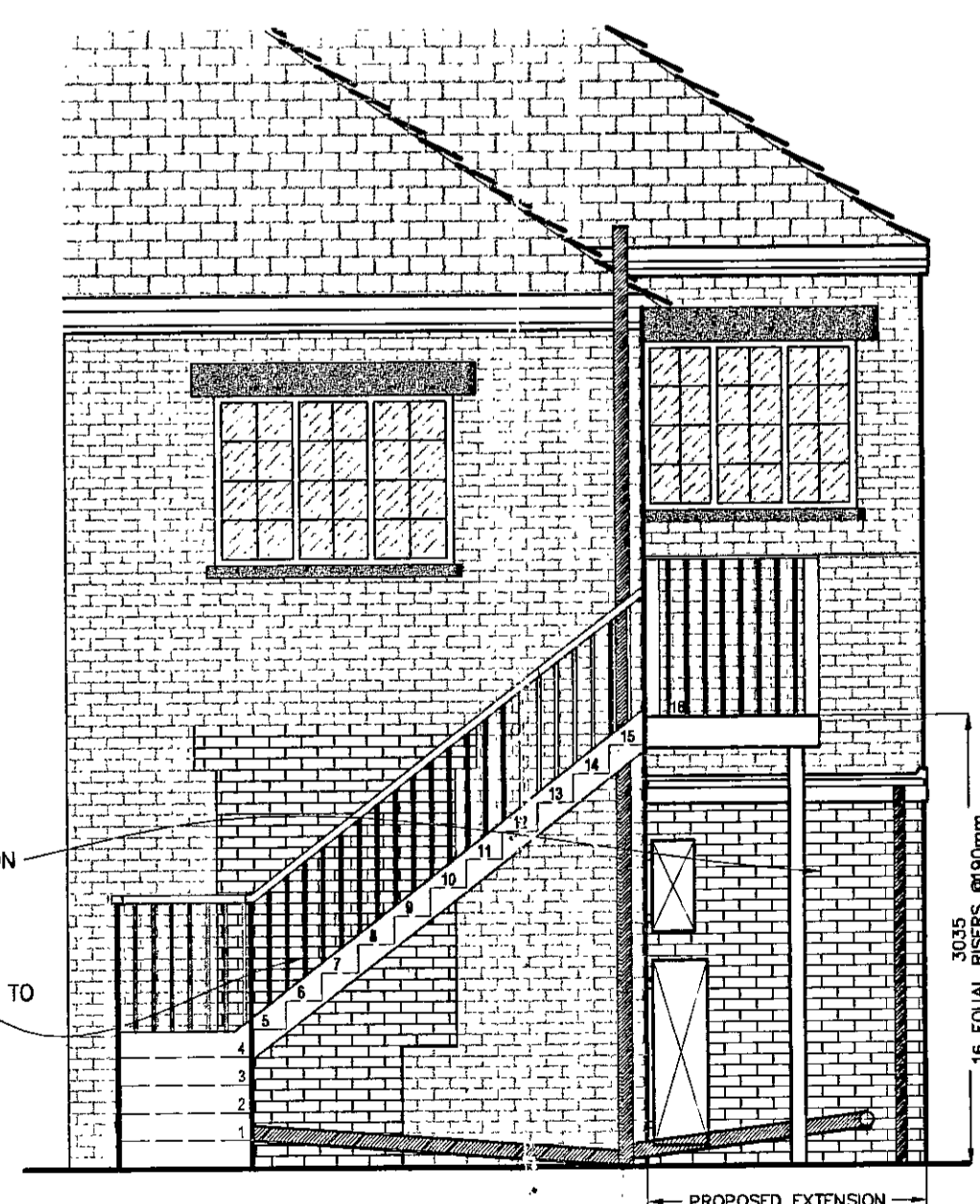

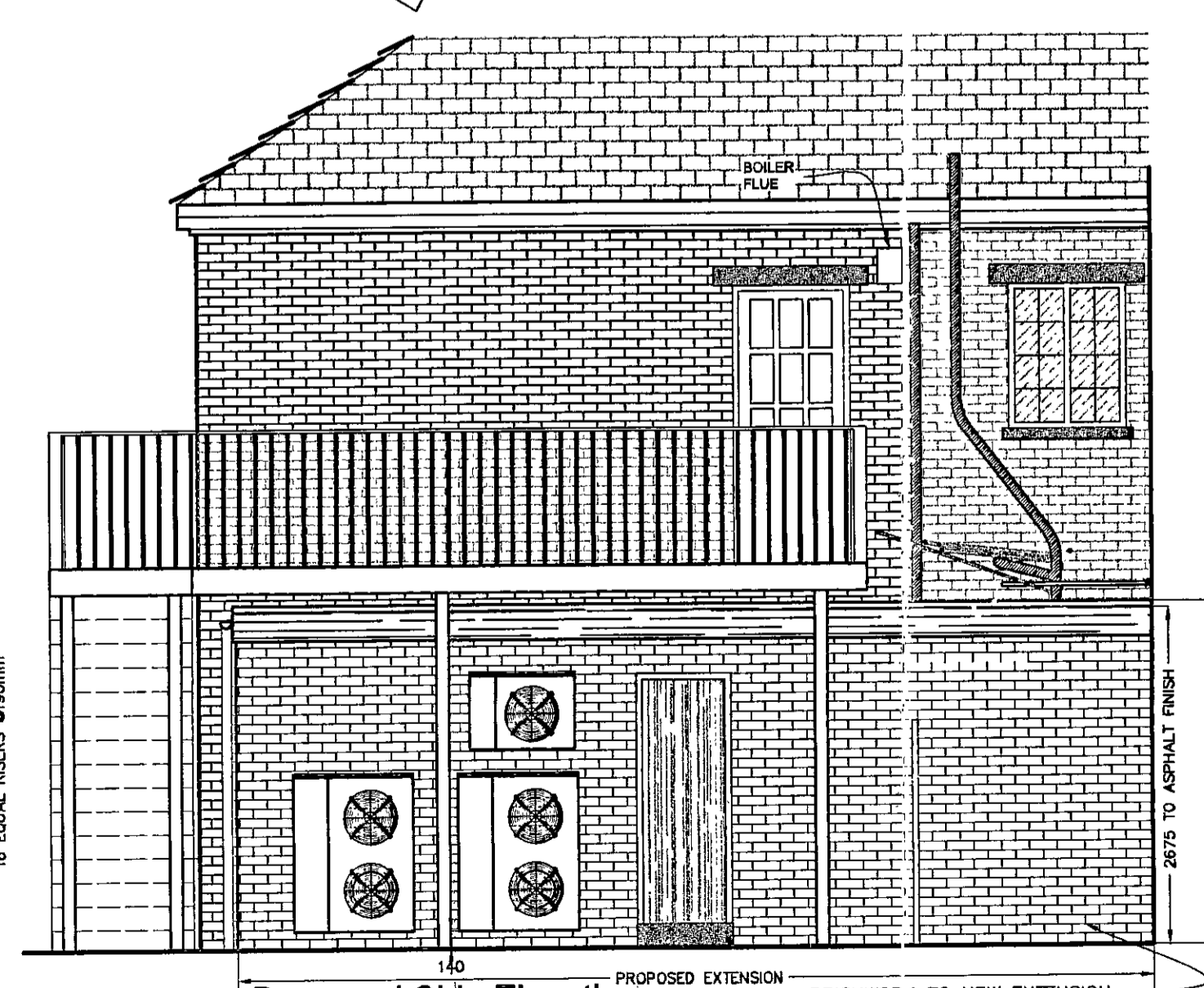

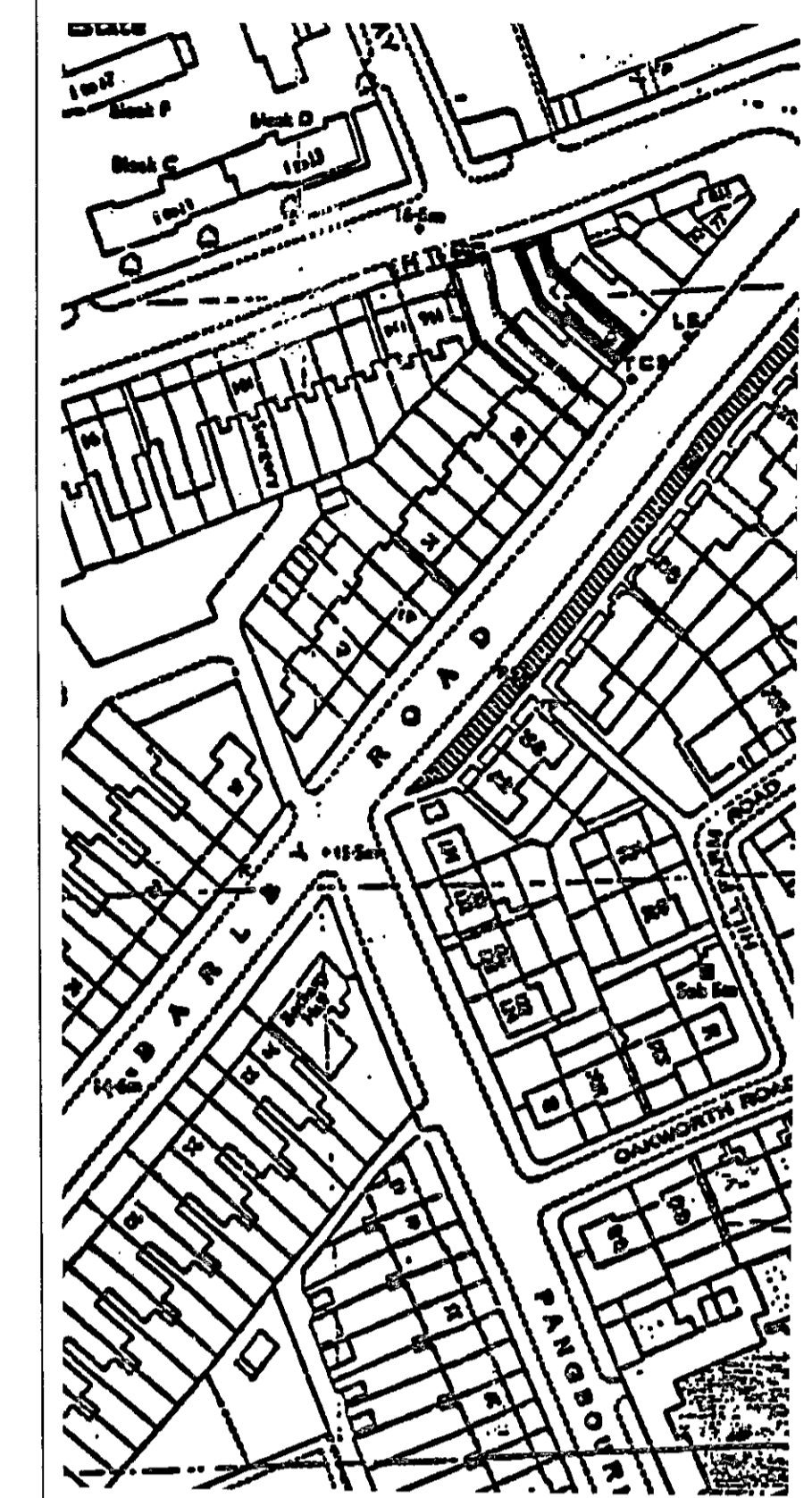

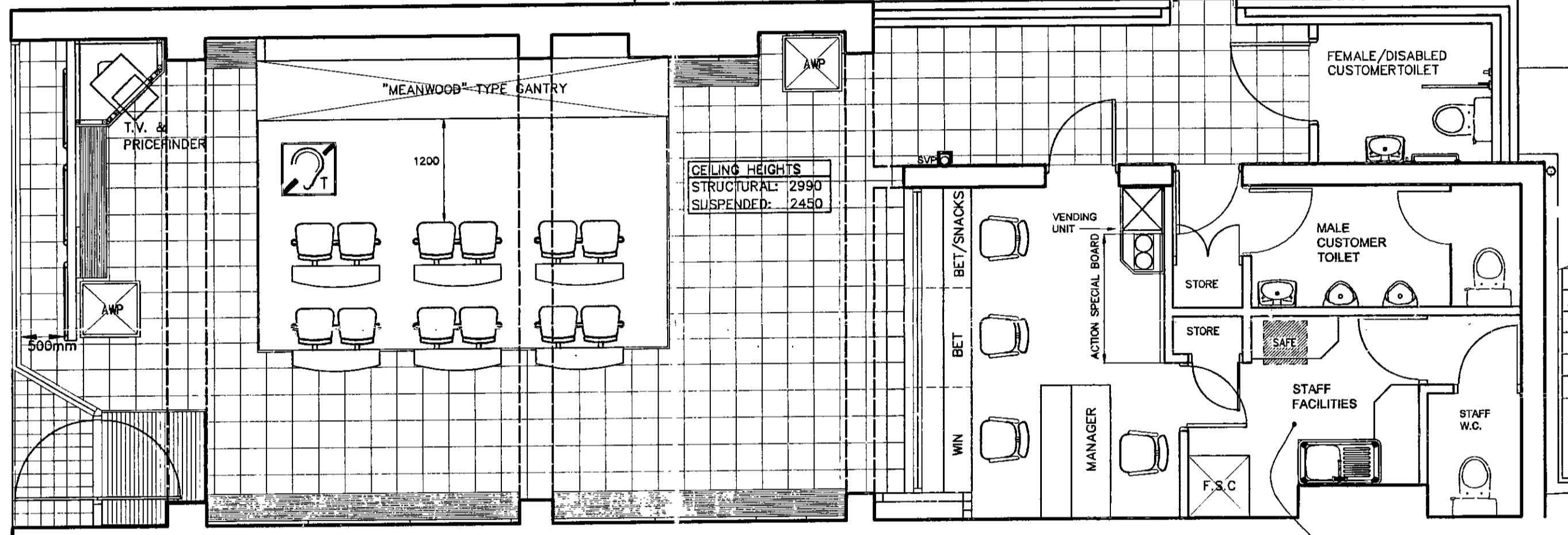

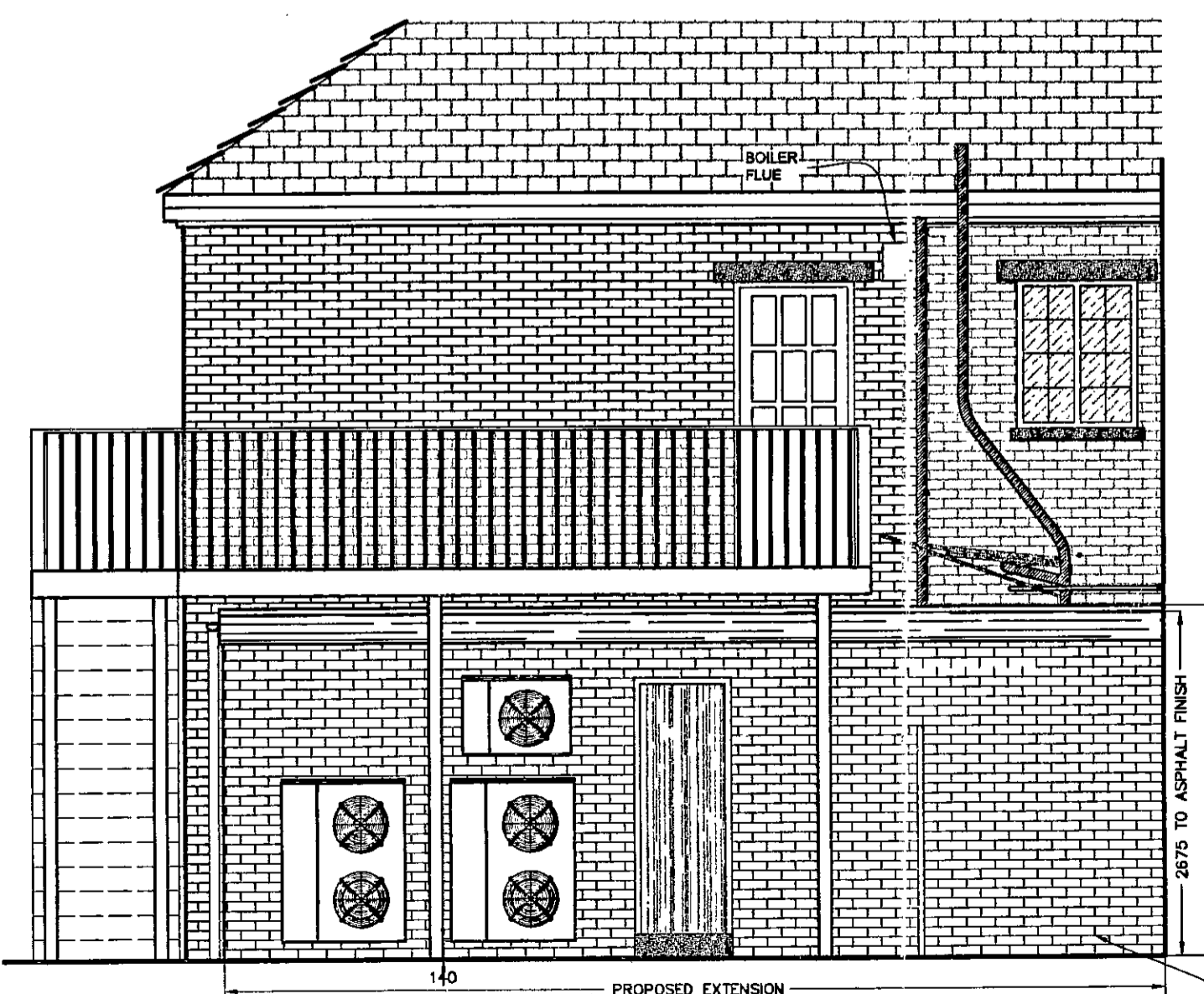

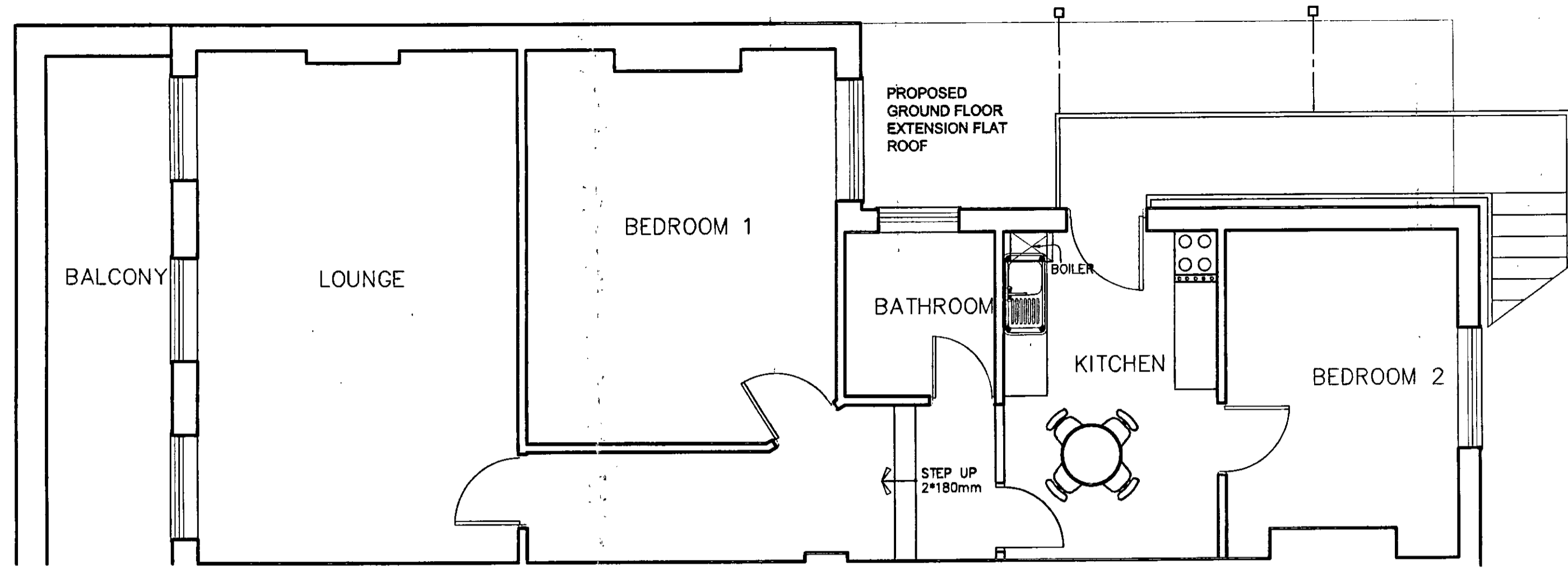

SHOWING REQUIRED ALTERATIONS TO FIRST FLOOR FLAT

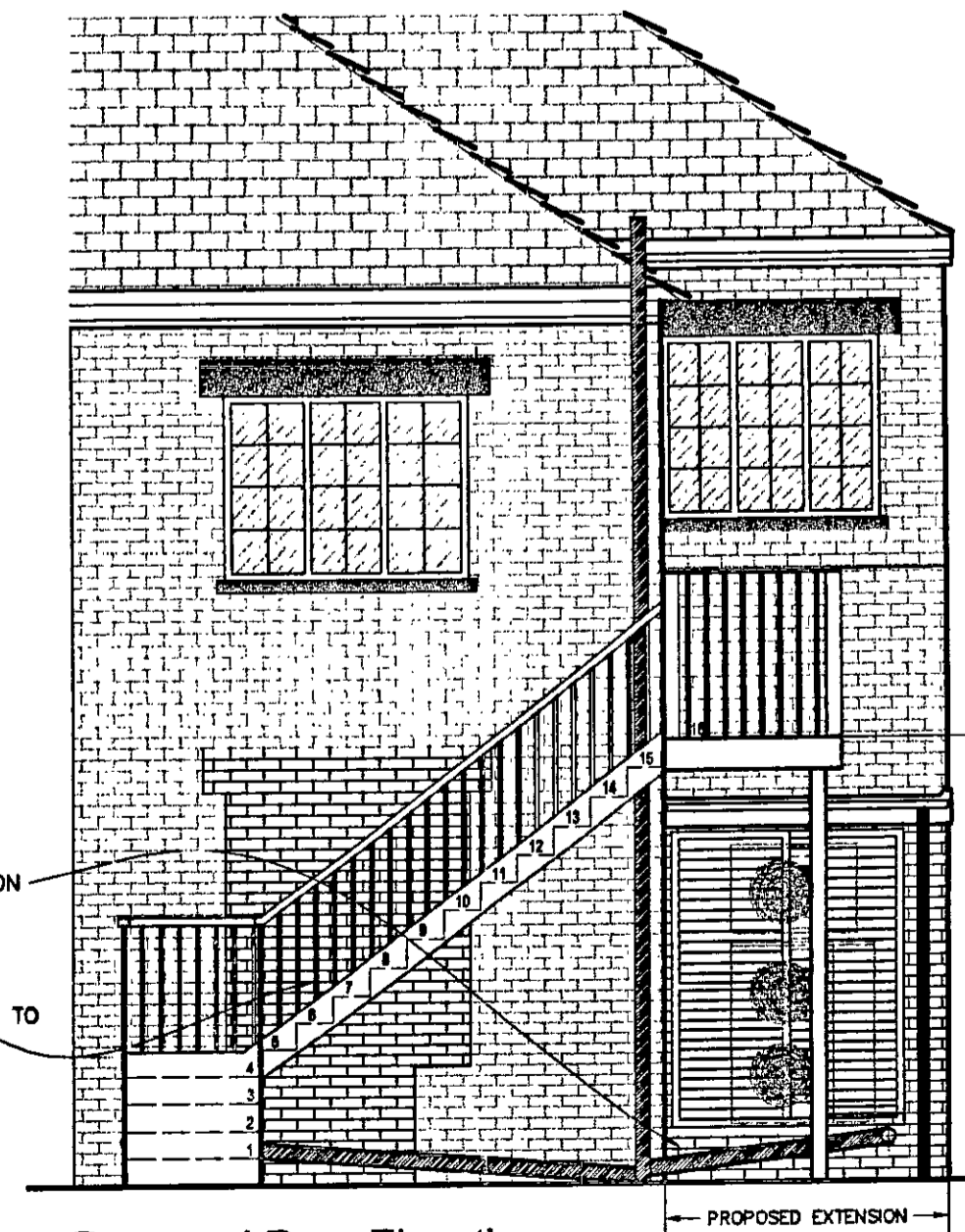

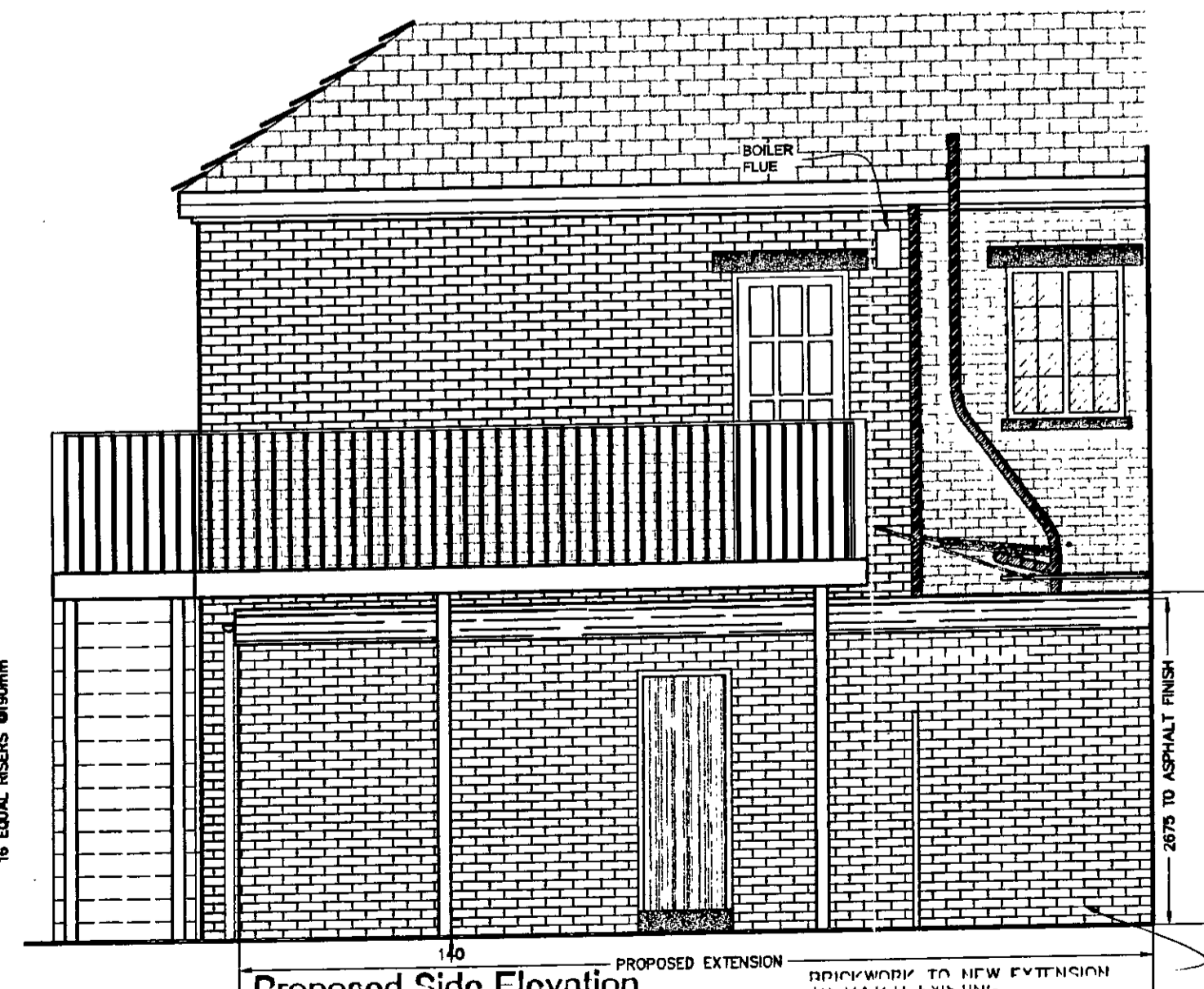

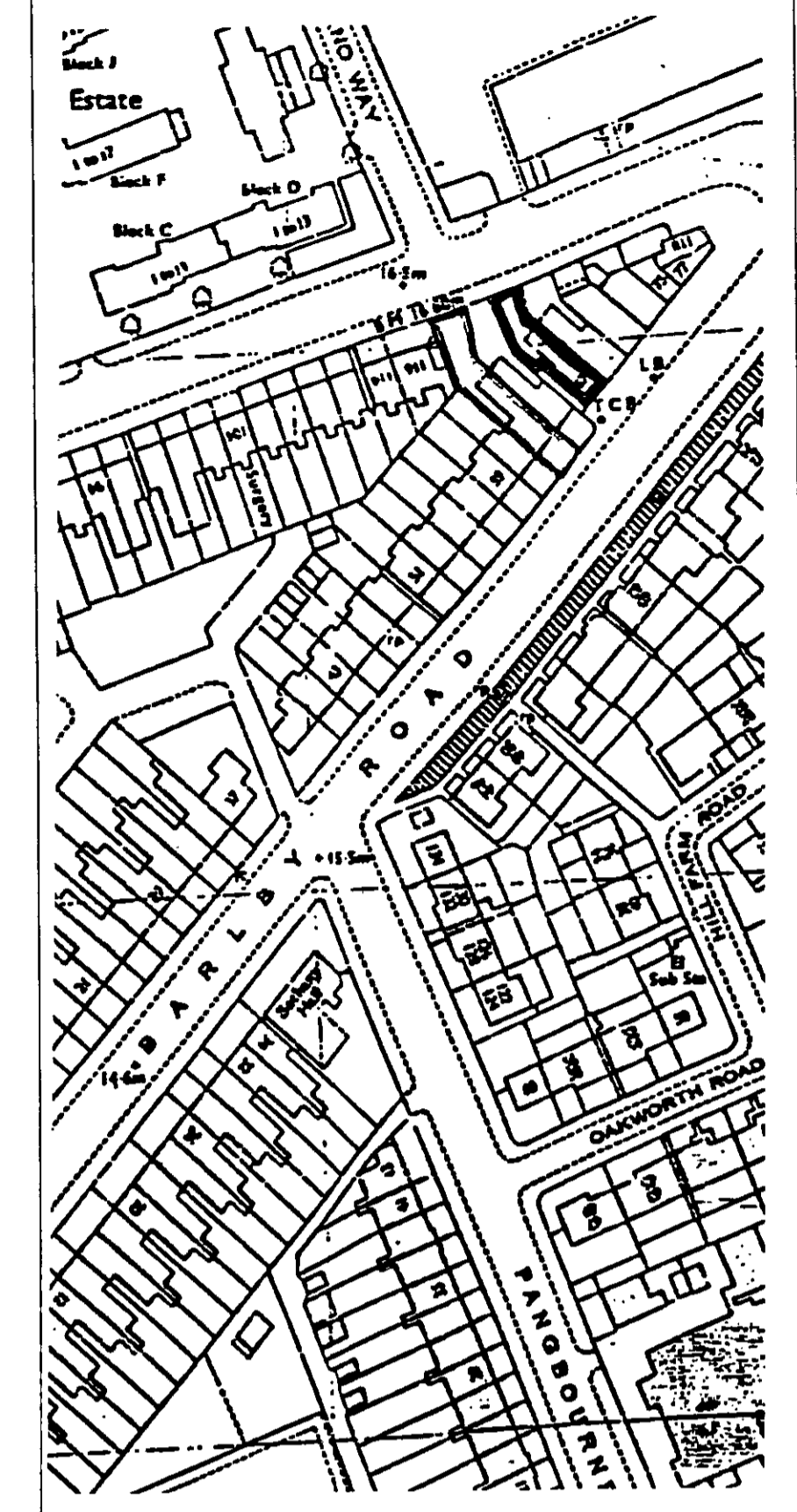

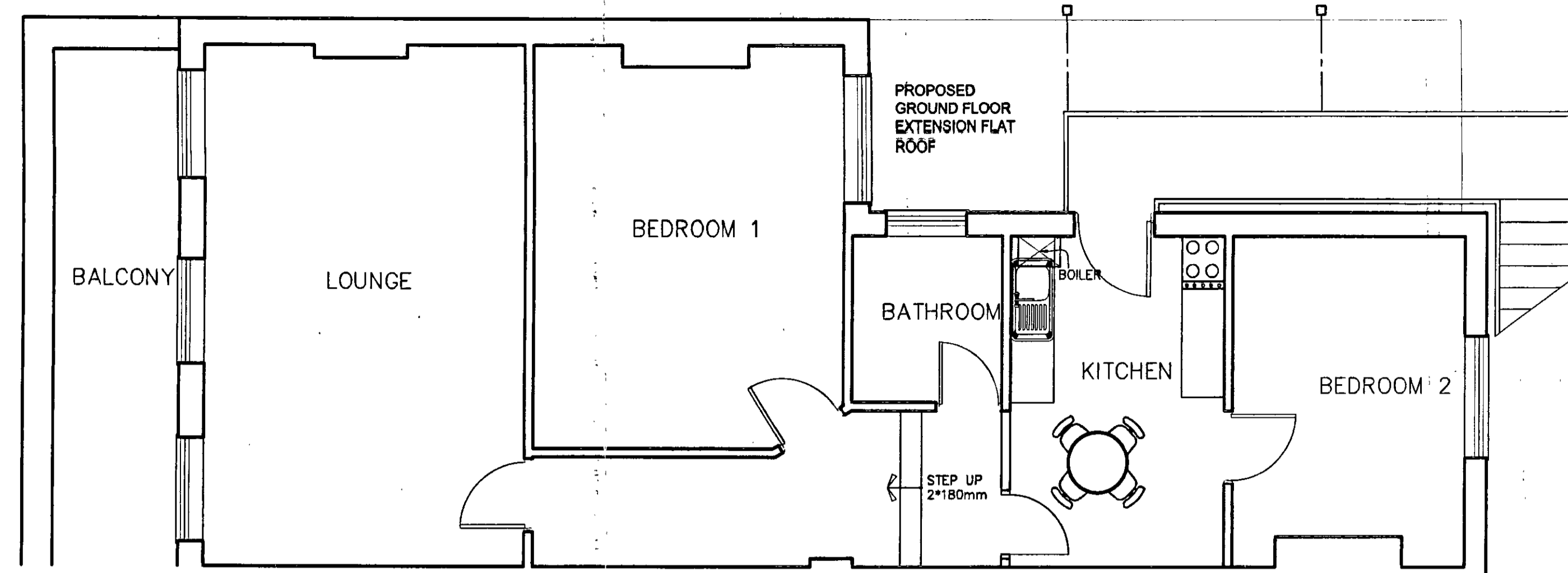

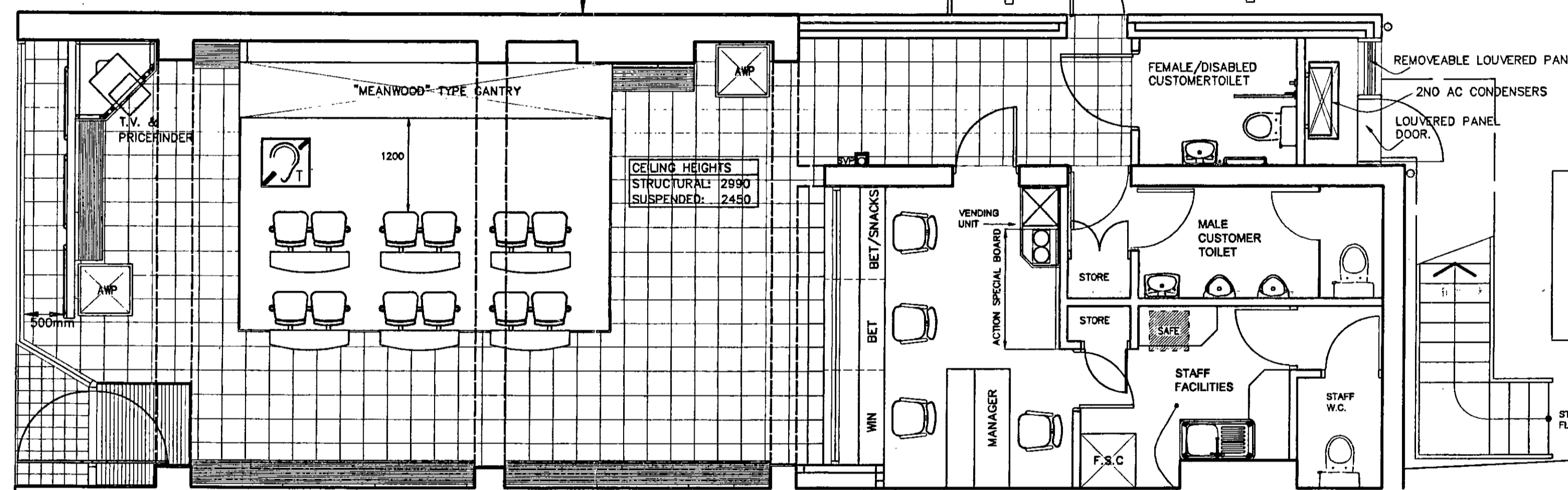

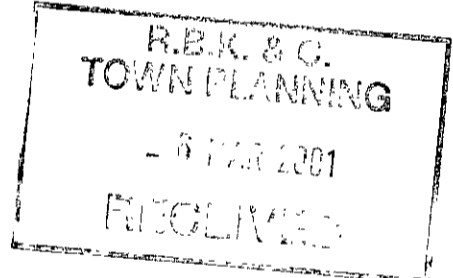

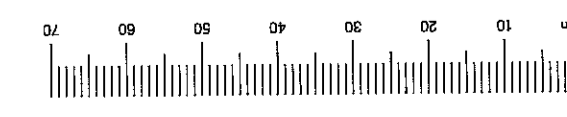
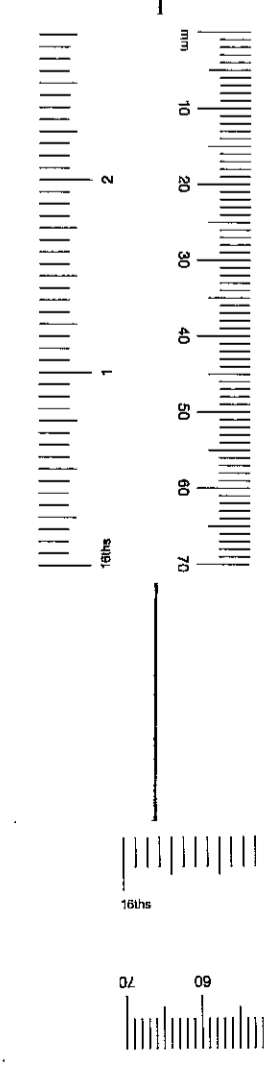

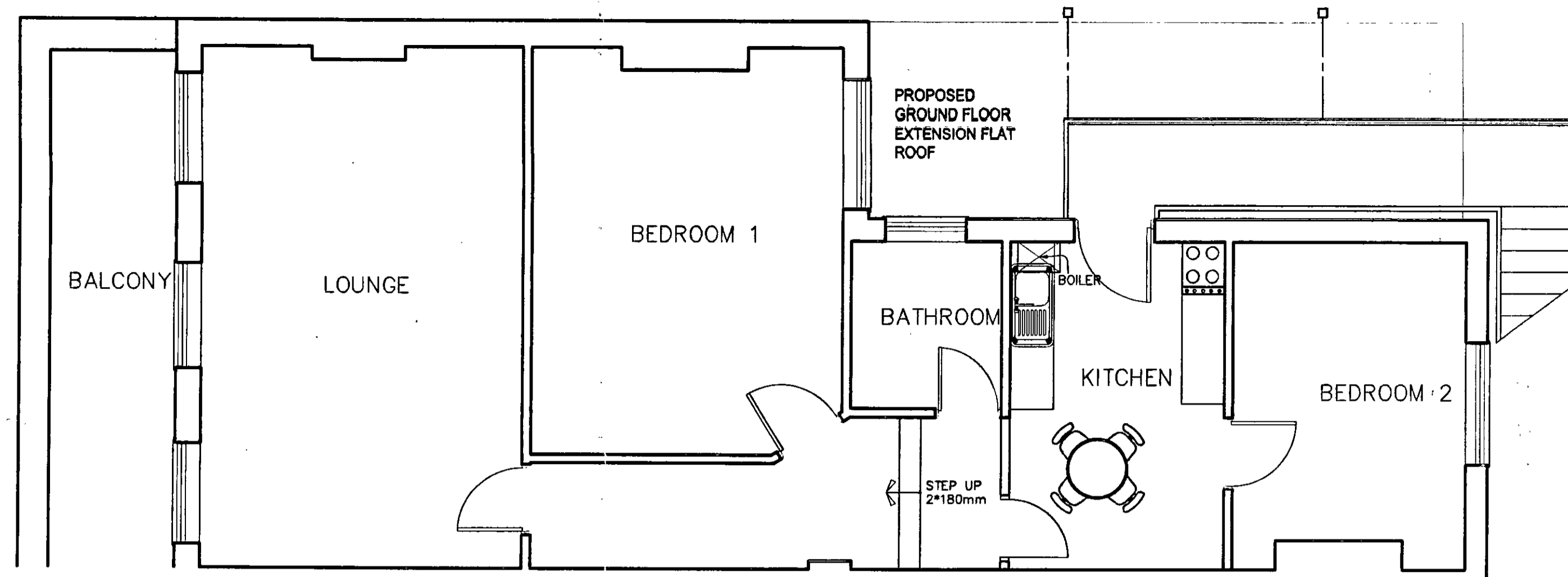

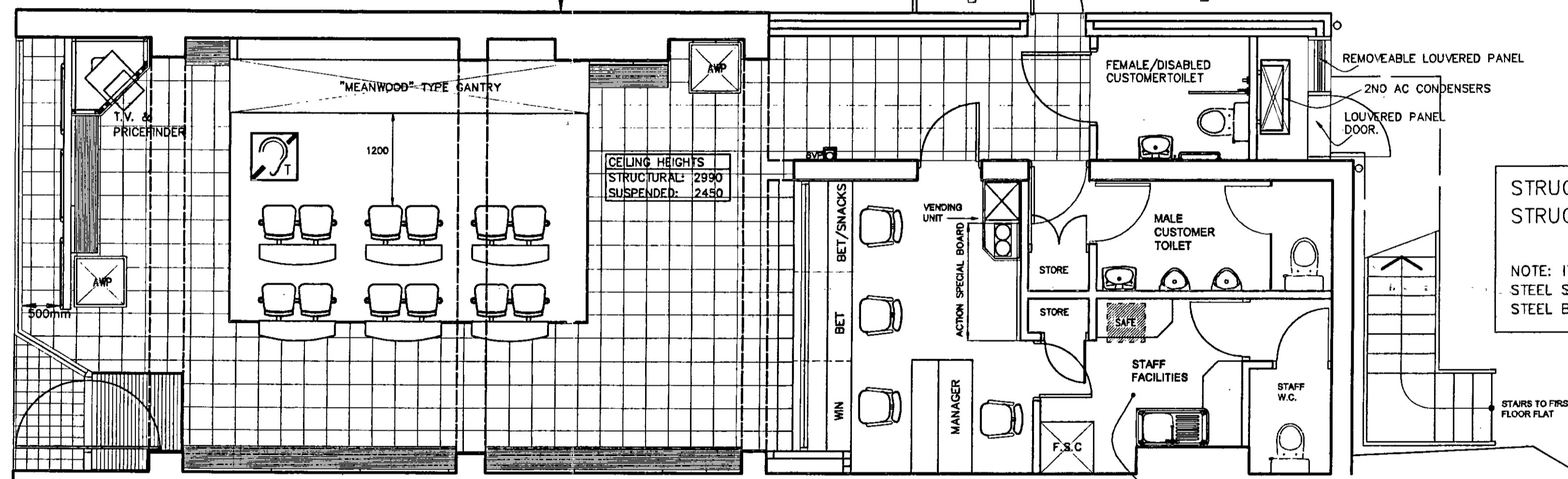

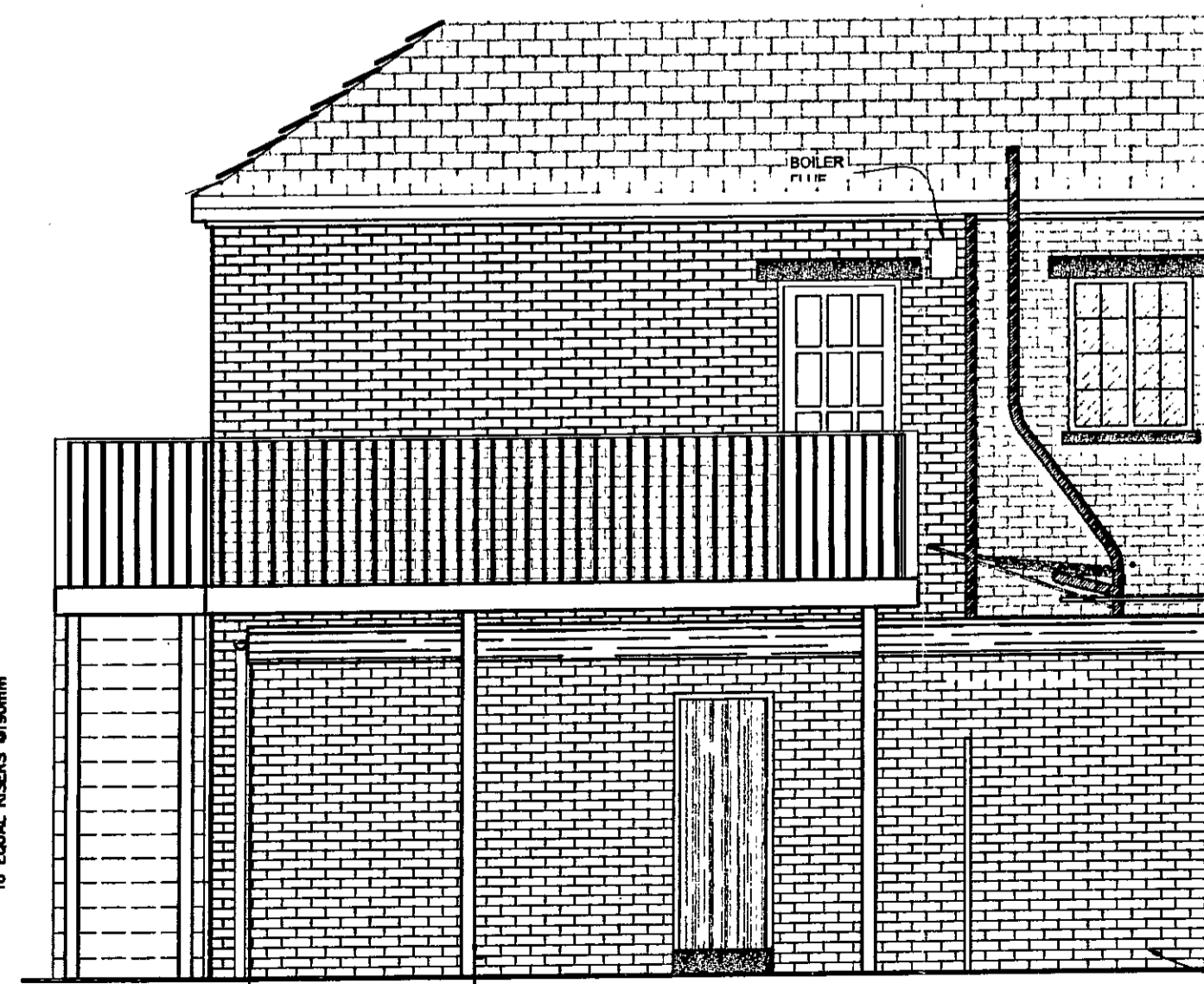
