

1. **The five louvres on the facade, the four fans, the lift between the fourth and fifth floors and the infilling of the eastern lightwell hereby permitted shall be removed and the sites restored to its former condition on or before 31/1/2005.**  
*Reason - The particulars hereby reserved are considered to be material to the acceptability of the development, and the local planning authority wishes to ensure that the details of the development are satisfactory. (R011)*
  
2. **The balustrading around the eastern lightwell shall be photographed and retained within the curtilage of the store for the duration of the works hereby permitted. When the works hereby permitted for the eastern lightwell are completed the balustrading shall be restored to the lightwell and permanently maintained thereafter.**  
*Reason - The particulars hereby reserved are considered to be material to the acceptability of the development, and the local planning authority wishes to ensure that the details of the development are satisfactory. (R011)*
  
3. **The works hereby permitted shall be carried out exactly and only in accordance with the drawings, and other particulars, forming part of the Consent, and there shall be no variation therefrom without the prior written approval of the Local Planning Authority. (C205)**  
*Reason - In order to safeguard the special architectural or historic interest of the building. (R205)*
