4	<p>LAND</p> <p>Any beneficial interest you or the relevant person have in land within the area of the Royal Borough of Kensington and Chelsea.</p>	No
5	<p>LICENCES</p> <p>Any licence (alone or jointly with others) you or the relevant person have to occupy land in the area of the Royal Borough of Kensington and Chelsea for a month or longer.</p>	No
6	<p>CORPORATE TENANCIES</p> <p>Any tenancy where (to your knowledge)—</p> <p>(a) the landlord is the Royal Borough of Kensington and Chelsea; and</p> <p>(b) the tenant is a body in which you or the relevant person have a beneficial interest.</p>	No

7	<p>SECURITIES</p> <p>Any beneficial interest you or the relevant person have in securities of a body where—</p> <p>(a) that body (to your knowledge) has a place of business or land in the area of the Royal Borough of Kensington and Chelsea; and</p> <p>(b) either—</p> <p style="padding-left: 20px;">(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p style="padding-left: 20px;">(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	No

Notes

1. Definitions

These descriptions of interests are subject to the following definitions;

"relevant person" means:

- Your spouse or civil partner*
- A person with whom you are living as husband or wife*
- A person with whom you are living as husband or wife as if they were your civil partner.*

"body in which you or the relevant person has a beneficial interest" means a firm in which you or the relevant person is a partner or a body corporate of which you or the relevant person is a director, or in the securities of which you or the relevant person has a beneficial interest;

"director" includes a member of the committee of management of an industrial and provident society;

"land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

"securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

2. Sensitive Interests

Where you consider that information relating to any of your interests is a 'Sensitive Interest' you need not include that interest on this form provided you have consulted with the Monitoring Officer and she agrees that it need not be included. A 'Sensitive Interest' is an interest which could create or is likely to create a serious risk that you or a person connected with you may be subjected to violence or intimidation.

Where the interest is no longer a 'Sensitive Interest' you must notify the Monitoring Officer within 28 days of that change.
