

# ADOPTION STATEMENT: NEW LOCAL PLAN REVIEW

In accordance with Regulations 26 and 35 of the Town and Country Planning (Local Planning (England) Regulations 2012 (as amended) this Adoption Statement gives notice that on 24 July 2024 the Council adopted its New Local Plan Review document which will be called the Local Plan 2024.

The New Local Plan Review was the subject of an independent examination conducted by Louise Nurser BA (Hons) Dip UP MRTPI, an Inspector appointed by the Secretary of State. In her report published on 5 July 2024 the Inspector confirmed that the Plan was sound subject to a number of main modifications.

The Local Plan 2024 comprises the following documents:

- The NLPR Publication Policies, October 2022
- The Inspector's Main Modifications (appended to the Inspector's Report) 5 July 2024
- The Schedule of Additional Modifications, January 2024
- The Policies Map

The Local Plan 2024 now carries full weight in the consideration of planning applications.

The Council will publish a consolidated single document in due course.

Any person aggrieved by the Royal Borough's Local Plan 2024 may make an application to the High Court under Section 113 (3) of the Planning and Compulsory Purchase Act 2004 on the ground that –

(a) the Local Plan 2024 is not within the powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2004; or

(b) a procedural requirement has not been complied with.

Any such application must be made no later than the end of the period of six weeks starting with the date the policies were adopted i.e. by the 4 September 2024.
