Athlone Gardens - Consultation on views of the Dog Agility area and proposed relocation

Introduction

Background

The Parks Project Team were keen to understand the usage of the dog agility area and equipment in Athlone Gardens, as well as preferences for the relocation of the dog agility area. Consultation would be considered ahead of commissioning for the proposed relocation of the dog agility area.

An online survey was promoted via e-newsletters and social media sites (Nextdoor, Facebook and Twitter). The online survey ran between 9 November 2020- 21 December 2020.

Methodology and report

There were 30 respondents in total. Not all respondents answered all questions. Where graphs are shown, actual number of responses are indicated (as percentage figures can be misleading with a small number of responses). Base numbers represent the total number of respondents for each question. Some questions were only asked to respondents based on how they answered previous questions, and some have abstained from responding all questions, so numbers will not always add up to 30 responses.

Results at a Glance

- A total of 24 respondents have used the Dog Agility area, with 17 of these respondents using the Dog Agility area on a daily basis.
- Of the 24 respondents who have used the Dog Agility area, 17 used the Dog Agility training equipment, with nine of these respondents using the equipment daily.
- A total of 23 respondents outlined that they would use the Dog Agility area in future.
- The majority (26 respondents) 'Agree' that the Dog Agility area benefits Athlone Gardens.
- A total of 22 respondents **'Disagree'** that the park should become 'dog on lead only' if the Dog Agility area improved.
- A total of 22 respondents highlighted that they would like to see more equipment added to the Dog Agility area, with 14 of these respondents highlighting that they would like to see **'Better facilities (e.g. shelter, water for dogs)**'added to the area.
- When asked about the preference for the relocation of the Dog Agility area, a total of 14 respondents chose 'Option 3 other' whilst 12 respondents chose 'Option 2 set further back in centre of park'.
- Of those that selected 'Option 3 other', a total of 11 respondents outlined that they would prefer a 'Combination of both option 1 and option 2'



- None of the respondents chose 'Option 1 - long, narrow design, adjacent to the playground' when outlining their preference for the relocation of the Dog Agility area.

- A total of five respondents used the Dog Agility area 'A few times per week'

- A total of 17 respondents highlighted that they have used the Dog Agility training equipment

Of those that said '**Yes'** to the above, respondents were asked how often they use the Dog Agility training equipment.

- A total of nine respondents highlighted that they use the training equipment '*Daily*'
- A total of five respondents used the training equipment 'A few times per week'

- A majority (22) of respondents highlighted that they would like to see other facilities added to the Dog Agility area in future.
- A total of eight respondents said they would not like to see other facilities added to the Dog Agility area in future.

Of those that responded **'Yes'** to the above, respondents were asked to outline what other facilities they would like added:

- A total of 14 respondents highlighted that they would like to see '*Better facilities (e.g. shelter, water for dogs)*' added to the Dog Agility area.
- A total of nine respondents said they would not like to see '*Improved dog agility equipment*'

- A majority (22) of respondents '**Disagreed**' that the park should become 'dog on lead only'.
- A total of seven respondents 'Agreed' that the park should become 'dog on lead only' if the Dog Agility area was improved.

Respondents were asked if they would like to see Dog Agility equipment installed in other parks throughout the borough:

- A majority (19) of respondents highlighted that they would like to see Dog Agility equipment installed elsewhere.
- A total of seven respondents said that they
 'Don't know' whether they would like to see
 Dog Agility equipment installed elsewhere.

- A total of seven respondents of highlighted that there should be a 'larger, separate space for dogs'
- A total of six respondents raised the issue of *'irresponsible dog owners'* and in particular the amount of dog mess that is left in the park.

Respondents were shown a marked map of proposed changes to the Dog Agility area and asked which option they would prefer:

- A total of 14 respondents chose 'Option 3 other location'
- A total of 12 respondents chose 'Option 2 set further back in centre of park'
- None of the respondents chose 'Option 1 long, narrow design, adjacent to the playground'

Of those that responded **'Option 3'** to the above, respondents were asked to detail their preferred location:

- A total of 11 respondents highlighted that they would like to see a 'Combination of both option 1 and option 2'
- Whilst a total of three respondents said they would like to see the relocation '*Further away* from the playground'

Respondents were asked to provide any further comments on the relocation of the Dog Agility area in Athlone Gardens. The comments submitted have been themed and outlined in the table below. Multiple themes may apply to the same comment.

- A total of eight respondents of highlighted that there should be a 'larger space for dogs and dog owners'
- A total of four respondents raised 'concerns over closeness to the playground' and the impact this could have on both dogs and children playing.
