### Introduction

The Infrastructure Funding Statement (IFS) is an annual report that the CIL Regulations<sup>1</sup> require to be published by December each year. The IFS provides a summary of the financial and non-financial developer contributions relating to Section 106 Legal Agreements (S106) and the Community Infrastructure Levy (CIL) within the Borough for the reporting year of 01 April 2020 to 31 March 2021.

It also includes a statement of infrastructure projects that the Council intends to be, or may be, wholly or partly funded by CIL.

Community Infrastructure Levy Regulations (2019 Amendment) Regulation 121A Schedule 2 Paragraph 1<sup>2</sup>

- a) The total value of demand notices issued for RBKC CIL in the reported period is <u>£6,152,093.74</u>.
- b) The total amount of CIL collected within the reported period was £1,739,242.38 and of this the total amount of Borough CIL (BCIL) was £1,384,931.75. The total BCIL collected was collected in Cash and there were no Land Transactions (including payments in kind and infrastructure payments).

 $\underline{\pounds 267,348.32}$  was collected for Neighbourhood (CIL) and  $\underline{\pounds 86,962.12}$  for CIL Admin. This may include RBKC CIL receipts where the demand notices were issued prior to the reported year and payment was received within the reported year.

c) The amount of CIL collected prior to the reported period (up until 31 March 2020) totals <u>£19,344,179.98</u> and the total amount of BCIL collected was <u>£15,440,359.20</u>. The total BCIL collected was collected in Cash and there were no Land Transactions (including payments in kind and infrastructure payments). <u>£9,741,000</u> of the BCIL has been allocated. The BCIL allocated includes allocations made in all year up 31 March 2021.
