# Audit underway on construction materials

**After thorough checks and safety advice from experts, Kensington and Chelsea Council has agreed with the headteachers and governors that both the new Kensington Queensmill School and Barlby School will open on time for the new term in September.**

This follows an investigation into the use of Kingspan products in the construction of the new school, and is a decision taken as part of a now much wider audit on buildings across the borough.

Kensington and Chelsea Council has also become the first local authority in the country to put in place a policy to limit the use of named companies currently involved in the Grenfell Tower Inquiry.

The Council is updating its website on a regular basis throughout the audit process, and will include details of products, what we plan to do about it, and what safety advice we have received.

# Next phase of easing lockdown

We are currently in phase three of the Government's easing of lockdown. This means that:

- The rule of six, or two households now applies inside
- You can sit inside in pubs and restaurants
- Cinemas and theatres are open
- You can stay overnight in other places
- Organised indoor sport starts again
- Weddings, wakes and other significant life events can have up to **30 people**. Funerals can have the capacity of the venue
- International travel resumes using the traffic light system.

At the time of print, the plan is for all remaining restrictions to be lifted from Monday 21 June. The Government will continue to monitor the virus and may decide this date needs to be pushed back. Search the web for "lockdown restrictions" to make sure you know the latest guidance.

# Vaccination and Testing

Nearly **66 million** doses of the vaccine have been given in the UK and, at the time of print, anyone aged **30 or over** can get their vaccine.

You can book online by going to [www.nhs.uk/coronavirus](http://www.nhs.uk/coronavirus) or calling the NHS on **119** free of charge. Nearly all first dose vaccines are now Pfizer, rather than AstraZeneca.

If you have any concerns about taking the vaccine you can find out more by visiting [www.rbkc.gov.uk](http://www.rbkc.gov.uk) and searching vaccination FAQ or speaking to your GP.

The vaccine reduces your risk of catching or having severe illness from Coronavirus and helps protect your family and friends.

The Government is also encouraging people to get tested twice a week to ensure they are not spreading Coronavirus without being aware as one-in-three people with the virus show no symptoms.

**To order free Coronavirus tests**, search "coronavirus tests" online. If you cannot order online, call **119**.

Lines are open 7am to 11pm and calls are free.

# Monday 14 June will mark four years since the tragedy at Grenfell Tower

**This time will be more difficult than usual for many people in North Kensington and it will be compounded by the on-going impact of Covid-19.**

Commemorative events will be taking place in North Kensington to pay respects to the 72 people who lost their lives in the tragedy, but we equally understand many people will choose to mark the day in private. If you do choose to attend an event we would encourage everyone to pay attention to social distancing and other Covid-19 related guidelines.

Much is still being planned, but we are expecting a range of different commemorative events including: the illumination of the Tower and other local buildings; bells of churches across London will ring 72 times at 7pm on Monday 14 June; online vigils and videos by churches and community groups; and private opportunities for bereaved and survivors to be able to pay their respects within the Tower site.

## Keeping safe

Although Covid-19 restrictions are gradually lifting, there are things you may need to consider to make sure that everyone stays safe.

For indoor events, you can meet with six people you do not live with or two households.

For outdoor events, up to 30 people can gather in an outdoor space. People should keep their distance

from others they do not live with or share a support bubble with. Remember, some people may not show symptoms and may unknowingly spread Covid-19 with their loved ones.

If you have a continuous cough, a headache or loss of smell and taste you should stay home.

These rules apply even if you've had the Covid-19 vaccine because you can still pass the virus onto others.

These regulations are correct at the time of print, to make sure you're following the latest rules, please search "Covid-19 restrictions".

# Residents help to influence future delivery of Grenfell community projects

**Residents' feedback is now helping to shape how future rounds of Grenfell Projects Funds (GPF) and Community Leadership Programmes (CLP) will be delivered following a recent consultation.**

The consultation ran from 18 February to 9 April 2021 and saw almost 100 responses about the GPF and 80 on the CLP. Thanks to everyone who we spoke to and who responded via the survey.

We've received a lot of feedback about how residents can be more involved in the design and delivery of both the Fund and Programme. The idea of creating a resident-led steering group or panel proved popular, so we are looking at the best way to go about this. Please keep an eye out for how you can get involved via the Council's website and other channels. ## Some other key feedback from residents on the GPF consultation was:

- Half of those who responded thought the GPF was a success and 64 per cent would recommend that a friend or neighbour apply to the GPF
- Almost half of respondents said the six themes should remain the same
- The majority of respondents favoured a combination of a resident-led steering group and a public vote for the decision-making process
- Residents would like to receive information about the GPF through the Council's social media platforms, texts, WhatsApp groups and face-to-face meetings. Many respondents felt that the website was the best place to get information about the Fund

## Feedback on the CLP highlighted:

- More than half of respondents said that they learnt new things whilst taking part in a CLP course and 49 per cent said that the CLP helped them think about what they can offer to the wider community
- Residents wanted courses and training to focus on fundraising, budget management, IT and community and bid writing
- Respondents were keen to have a combination of a resident-led steering group and an online voting process to decide what courses should be delivered as part of the CLP
- Respondents would like to receive information about the CLP through the Council's social media platforms, texts, WhatsApp groups and face-to-face meetings. Many respondents felt that the website was the best place to get information about the CLP
- The need for improved marketing of the CLP to engage more residents

# Lancaster West's first low-energy home

**Lancaster West Neighbourhood Team (LWNT) is excited to present the first low-energy council house in Kensington and Chelsea on Verity Close on the Lancaster West Estate. This is part of the ambition to become a carbon neutral estate by 2030.**

Working with ECD Architects, the team took a whole-house approach to improve energy efficiency in the three-bedroom property, meaning it is warmer in winter, and with significantly reduced energy bills for residents. The house has many sustainable features including 16 solar panels, triple-glazed windows, upgraded insulation (which is non-combustible), an air source heat pump and mechanical ventilation heat recovery system.

LWNT's director James Caspell said:

***"This shows that it is possible to transform existing council homes into low-carbon high-quality places to live. We will use the learning from the project to benefit the wider estate. We now have a unique opportunity."***

# Key workers move into homes fit for heroes

**Key workers who served on the front line of the Covid-19 pandemic are settling into modern new homes provided through a Kensington and Chelsea pilot programme.**

Under the key worker accommodation scheme, 14 flats on Kensal Road in North Kensington were offered at affordable rents to NHS and education professionals who serve the borough's residents.

The Council received more than 325 expressions of interest in the one-, two- and three-bedroom properties, with the levels of demand now being used to develop a full key worker housing policy for the Council.

The key worker properties are offered at "intermediate" rents, which is affordable housing for those unlikely to access homes at social rent levels, but who may not be able to afford open market rates.

# Construction begins on new Kensington and Chelsea council homes

**Plans to deliver 600 new council-owned homes in Kensington and Chelsea are a step closer to becoming reality after building work began on two sites in the borough.**

Construction is now underway on 37 homes and community and commercial space adjacent to Our Lady of the Holy Souls Church on Kensal Road, with an additional 20 homes being built on Hewer Street opposite St Charles' Hospital.

The Council has appointed Willmott Dixon to complete the schemes, which were designed following public consultations and are expected to be ready for residents in late 2022 or early 2023.

The developments are part of the Council's New Homes Delivery Programme to build 600 homes – at least 300 at social rent – on Council-owned land.

The Ministry of Housing, Communities and Local Government (MHCLG) has written to bereaved families, survivors and local residents about a decision on the future of Grenfell Tower.

# North Kensington residents have their say on future support services

**More than 240 people had their say in a recent consultation looking at how we could improve emotional health and wellbeing support for adults and young people in North Kensington who have been affected by Grenfell.**

The Council has been working with some brilliant grassroots providers to deliver services for the North Kensington community, including services offered under the 'Together 4 Grenfell' umbrella for adults.

With three years of the Grenfell Recovery Programme remaining, we wanted to work with the community to gather feedback to help us shape the next phase of support. We have been working with the current Together 4 Grenfell providers, children's emotional health and wellbeing provision in schools and the community to develop service proposals and have been speaking to our health and community and voluntary partners to support this and to help us plan for new services.

The adult's consultation, which ran from 1 February to 26 March 2021, resulted in 97 survey responses and 37 stakeholders attending three focus groups. An online consultation for youth services was launched on 27 January 2021 and ran until 26 March 2021 with almost 140 survey responses from schools, partners, residents, parents, and children and young people who also took part in focus groups.

## Adult's consultation headlines:

- 77% currently using local services to support their emotional health and wellbeing needs
- 92% currently using Together 4 Grenfell services said they were very good or good
- 89% using Together 4 Grenfell Services told us their emotional health and wellbeing had significantly improved or slightly improved
- There is a strong feeling that despite some improvements in emotional health and wellbeing that there was a clear ongoing need for these services
- There is strong positive feedback on the provision for those currently receiving support

## Where we could improve:

- 69% felt emotional health and wellbeing support for young adults was an area of need
- 66% felt support groups were needed
- 57% felt support for elders to tackle social isolation and loneliness was a gap

As a result of the feedback, the Council's Leadership Team were asked to agree a series of recommendations based on residents' feedback. We will be looking at an enhanced counselling and wellbeing service for adults and we will be offering additional therapy to over 50s to help tackle isolation.

For young people, the Council recognised the positive feedback from the consultation on existing provision and agreed to fund existing providers in schools and community-based settings to deliver refreshed and rescoped emotional health and wellbeing services in line with the consultation themes. We will also make funding available to new community initiatives that meet our criteria which is planned for launch in late June/July.

We are also developing a peer support programme for adults in the local community to launch this summer.

We will be working with residents and partners to increase the reach of all initiatives wherever we can so that we can reach as many local people as possible through these initiatives.



It's vital that you apply before the deadline to be able to continue to live and work in the UK. It's free to apply and you can complete the first application stage via your smartphone with the Home Office's 'EU Exit: ID Document Check' app. If you don't have access to a smartphone, our EuSS (European Settled Status) service team can help you with starting your application.
