(a) Title of Document

The Core Strategy for the Royal Borough of Kensington and Chelsea with focus on North Kensington.

(b) Subject Matter

The Core Strategy sets out the vision, objectives and detailed spatial strategy for future development in the Royal Borough up to 2028 along with specific strategic policies and targets, development management policies and site allocations. The document does not just consider land use, but also a comprehensive range of environmental, economic and social issues.

The Core Strategy covers the entire Borough.
